  - Encourage reduction of waste at the source, and
  - Foster implementation of integrated solid waste management systems that are cost-effective and protect human health and the environment.
- ◎ The guide includes comprehensive chapters on the following topics: Public Education and Involvement; Facility Siting and Permitting Develop and Waste Management Program; Collection and Transfer; Source Reduction; Recycling; Composting; and Land Disposal

# Recycling Economic Information Study (2010)

- ◎ This Study (which we hope to update soon) presents both the direct economic impacts of the recycling and reuse industries in Illinois, as well as estimates of indirect and induced impacts. An attempt was made to model the indirect and induced impacts associated with all of the recycling, recycling reliant and reuse industries without double counting. Based on a “whole model approach” it is estimated that the combined direct, indirect and induced impacts of Illinois’ Recycling, Recycling Reliant and Reuse Industries are roughly responsible for:

<u>Impact Type</u>	<u>Jobs</u>	<u>Payroll</u>	<u>Gross Receipts</u>	<u>State and Local Taxes</u>
Direct Effect	40,000	\$1.5 billion	\$17.1 billion	\$564.3 million
Indirect Effect	34,000	\$1.2 billion	\$7.1 billion	\$234.3 million
Induced Effect	37,500	\$886 million	\$6.1 billion	\$201.3 million
<b>Total Effect</b>	<b>111,500</b>	<b>\$3.6 billion</b>	<b>\$30.3 billion</b>	<b>\$1 billion</b>

# Illinois Commodity/Waste Generation and Characterization Study (May 2015)

- ◎ This report documents the types and quantities of materials generated in Illinois, the generating sectors, the quantities that are potentially recoverable and those that are otherwise landfilled. The study also sheds light on how much value there still is to capture and where it might be most economical to do so. This data can enable sound policy and program design, implementation and program analyses for both the public and private sector. The data can be used for strategic planning; developing legislative initiatives; evaluating effectiveness of current recovery efforts; targeting programs and educational efforts to advance recovery of commodities; providing guidance to state agencies and local governments; and aid in fulfilling the responsibilities under the Illinois Solid Waste Management Act, the Solid Waste Planning and Recycling Act, and the Illinois EPA Act by local governments or management districts.
- ◎ Illinoisans discard nearly \$1 millions a day of recyclable commodities!
