



Based on CARE's national estimate of 14 pounds of carpet per person per year, and an Illinois population of 12.8 million, we might estimate that the amount of carpet discarded annually in Illinois is **around 180 million pounds**.

However, based on the 2009 *Illinois*Commodity/Waste Generation and
Characterization Study\*, it could actually be as
high as 560 million pounds. According to that
same study, carpet and padding are 2% of what
is landfilled in Illinois.

### Foundation of Understanding

- Carpet recycling presents unique challenges: bulky, many materials, needs to remain dry.
- There are various methods of collecting carpet.
- Residential waste collection programs, offering bulk-item pick up for free or low cost, deliver all material to landfill.
- PET is currently difficult to recycle, and presents a cost burden for processors, which threatens the longevity of the current voluntary market-driven approach.
- Process of identification, transportation and processing carpet has high costs.
- Manufacturer responsibility for Design for Environment principals and the end-of-life process of the product.
- Retailers state lack of space for storage, Installers see little incentive

## EPR Bill for Carpet and Pad: 2014 & 2015

- IL Carpet Recycling Working Group (CRWG), established in March 2013, and representing approximately 25 stakeholders supports introducing an EPR bill in 2014 for carpet and pad. Primary reasons are the continued growing market share of PET carpet that is threatening the economic viability of carpet collectors/processors, and the fact that carpet and pad account for about 2% of landfilled materials in IL or 280,000 tons per year.
- The Legislative and Policy Subgroup of the CRWG has developed the broad parameters of an EPR bill:
  - Carpet manufacturers required to utilize CARE as stewardship group
  - ➤ A carpet assessment fee will be specified in the bill for PET/PTT/blended carpet fibers only (nylon and polypropylene no fee)

# SB 1433: MOU Provisions

- 1. Designate a CARE/CRI employee as the project manager for Illinois and assist with the administration of the IL Carpet Recycling Working Group and the growth and role of the CRWG in helping educate the public and affected stakeholders (e.g., retailers, installers, recyclers, local government, waste industry), and expanding the collection network in the State. Should dedicate at least 400 hours/year. Possible formal alliance with SWANA-IL Chapter and ILPSC.
- 2. Assist in the development and implementation/maintenance of a record keeping system to track the collection and management of post-consumer carpet on a statewide basis. Ultimate goal is to understand how much carpet is being diverted, how it is being diverted/processed and ultimately managed.



- 3. Provide research funding to an IL state university and/or research body (e.g. Argonne National Lab) to focus on finding viable markets for PET, PTT and blended carpets. Such markets should focus on IL based uses for carpet as a priority.
- 4. Provide a grant program of great enough value to attract an end use market user into IL. One possible company is Fiberon Decking.
- 5. Provide a grant program of great enough value to recyclers for capital items such as equipment and building upgrades that will help recyclers become more profitable.



- 6. Assist in creating a dialogue with retailers and installers to increase collection opportunities (in conjunction and with the support of the CRWG). Goal would be to have retailers provide drop off locations for patrons of their store. This will help capture carpet from both the installers and the do-it-yourselfers. Also assist in creating a dialogue with construction and demolition debris recyclers, and the waste industry in general on developing a more robust collection infrastructure.
- 7. Develop a Carpet Stewardship Plan, with the input of the CRWG and other interested stakeholders, specific for Illinois with provisions similar to those listed in SB 1433 and have it finalized by January 1, 2016.



#### **Provided from the Carpet Manufacturers as Next Steps:**

- 1. Baseline Illinois Carpet Collection, Diversion and Recycling (90---120 days)
  - a. Survey all known collectors, sorters and processors of Illinois PCC
  - b. Get Illinois sales data estimates from Torcivia
  - c. Create Illinois Carpet Recovery report

# Illinois Carpet Recycling Stakeholders Group

- 2. Interview all key players to identify potential opportunities (60---90 days)
  - a. Collectors and Processors (Mark Lienhart and Glenn Odom (Wellman/DC Foam), Nick Fiore, Kasey Wakefield and Dick Kruse, others?
  - b. Targeted Illinois Retailers, Starnet, Resource, CCA Global, others?
  - c. Government representatives from municipalities
  - d. Walter Willis, et al
- 3. Develop strategic projects for initial focus, i.e. (after interviews)
  - a. Increased diversion and collection with DC Foam
  - b. Commercial collection thru Kruse Recycling
  - c. Potential project TBD with Nick Fiore of CLEAR
  - d. Possible communication/education materials for municipalities
